



## TERMS AND CONDITIONS OF HIRE

Please read the below terms and conditions of hire

**HIRE RATES:** Rates are calculated on a 24 hour period. Any hire after this 24 hour period will be charged as another days hire.

**EQUIPMENT OFF HIRE:** Please call a Payne Hire representative on 0474 122 205, equipment will remain on hire until Payne Hire is contacted.

**PERMITS AND REQUIREMENTS:** Please be aware as the hirer you are responsible for researching and gaining permits that may be attached to the signs placement. Permits can be obtained from local government bodies and road authorities, if you the hirer or Payne hire are contacted to remove a sign by any governing body, Payne hire will turn sign off and collect ASAP, and any costs incurred will be at the hirer's expense.

**GOVERNMENT INFRINGEMENTS:** Payne Hire reserves the right to on charge/forward any infringements received from trailer location and or incorrect placement without council approvals, this includes speeding penalties if sign is on customer's car.

**PAYMENT:** Payment is required before delivery for COD hires, and 30 days from date of invoice for account customers. Payment can be made via EFT,

**EQUIPMENT RESPONSIBILITIES:** The hirer is responsible for the sign in regards to damage, theft, third party damage, the equipment remains on hire until all repairs incurred during hire are repaired. Please report any damage to a Payne Hire representative on 0474 122 205 with supporting photos. If Damage or equipment stolen, a police report will need to be filed.

**DAMAGE WAIVER IS NOT APPLICABLE:** If any of the following is damaged or lost the Hirer is bound to pay the cost of a batteries, solar panels, tail lights, stabilizer legs, trailer leads or plugs, Jockey wheel, wheels & rims, Padlocks,

**DAMAGE WAIVER:** An optional fee of 10% of the hire Invoice amount is available for the insurance of a sign up to the first \$2000 worth of damage, a \$250 excess is to be paid in this instance.

### **MAJOR DAMAGE/ TOTAL LOSS- COVER**

This option is at a charge of \$20 per day plus GST, this cover is for the total loss/damage to the sign less a \$2000 excess. The option includes the Damage Waiver detailed above. The first \$2000 damage is covered under Damage Waiver; the next \$1500.00 is the excess payable by the Hirer under the Total Loss/Damage Cover. Any costs above this are covered by this option. If a hirer picks up the sign, this cover is not applicable.

### **NON ELECTION OF COVER:**

In cases where the hirer elects not to take the option of the 10% Damage Waiver Insurance or Total Loss/Damage Cover, the hirer shall be responsible for the payment of all costs incurred in relation to damage or theft sustained.
